PAYMENT PLANS THROUGH **FACTS** Tuition Management

Full Payment Plan = One payment of the annual tuition paid by
 August 1, 2016.
 {5% discount if paid by May 1, 2016 or 2.5% discount if paid by July 1, 2016}

Two Equal Payments = Two payments: One half of annual tuition paid on August 1, 2016
 Second half of annual tuition paid on February 1, 2017

Ten Month Payment Plan = Ten equal payments to be made on the 1st of each month
 August 1, 2016 through May 1, 2017

1. Payment Dates:

- **Tuition payment is due the 1st of each month, August, 2016 – May, 2017.**
Automatic payment can be made via checking account, savings account, or credit card.
- **The General Fee per family is due and payable to FACTS on May 1, 2016.**
- **For families who would like to pay their tuition bill in full and take advantage of the 5% discount, this payment and the General Fee must be made by May 1, 2016.**

2. Enrolling in FACTS:

- All GCAE families must enroll in FACTS by going to our website: www.goodcounselelementary.net and clicking on the FACTS payment plan icon.
- FACTS paper application forms may be obtained from office or Mr. Mancuso.
- FACTS enrollment fees are paid by GCAE.
